- Conduct an Electrical Safety & Compliance check on all electrical installations, fittings and appliances
- Conduct a thorough switchboard inspection
- Insulation resistance testing on all fixed cabling and safety switch test
- Check all accessible power points and light switches, conduct an earth and polarity test on all points
- Provide digital Electrical Safety & Compliance Report issued after each check
- Inspect, clean and maintain all smoke alarms
- Replace any expired, faulty or damaged smoke alarms, including replacing any batteries as required
- Relocate any incorrectly positioned smoke alarms
- 🗹 Check all alarms meet required Australian standards
- Certificate of Electrical Safety supplied if applicable

#### **Smoke Alarms**

- Unlimited call outs for beeping or defective smoke alarms
- Free replacements of any defective smoke alarms
- Free relocation of any non compliant 9v smoke alarms

- Excludes smoke alarms that are linked to a security or fire system

#### **Electrical Compliance Testing**

- All fixed electrical appliance/fittings must be easily accessible
- All light fittings/ power points and switches must be easily accessible
- Does not include any items under the house, inside or on the roof, including solar arrays.
- Excludes any rectification works
- If any item is deemed dangerous and requires immediate attention. The item will be made safe and a quote submitted for rectification.
